Mapping Issue

This memorandum is to advise you of a mapping error made to the Volusia County, FL Countywide (CID 125155) Flood Insurance Rate Map, Suffix H, which became effective February 19, 2014. An incorrect publication date of the digital dataset 4/1/2010 was entered as the flood insurance prohibition date for all of the CBRS areas in Volusia County. The actual flood insurance prohibition dates in this county can be as far back as October 1, 1983.

This is a significant error that could allow property owners whose homes were built prior to 2010 to obtain invalid "grandfathered" flood insurance policies using the false 2010 prohibition date shown on the FIRMs. This error could also result in homes being incorrectly shown to be "in" or "out" of the CBRS. There may be more than a hundred single-family homes and more than a dozen condominium buildings that are affected by the error in the prohibition date.

NFIP Bureau Underwriters are in contact with the NFIP Servicing Agent and each WYO Company that has reported policies written using Suffix H map data in any of the five NFIP communities affected. We recommend that insurers review existing policies as well as any applications for coverage in these communities to ensure eligibility.
